 - DM/23/1771 Mrs S Elson, The Courtyard, North Street T1 Bay Tree - Remove lower branched to give 1m clearance over garage roof. T2 Liquidambar - Crown lift to 2.5m from ground level. T3 Birch Tree - Crown reduction by 2.5m in height and 2m in radial spread. T4 Cornus - Crown reduction by 1m in heigh and radial spread. T5 Conifer - Fell.

- DM/23/1702 Mr B Liles, Chimneys, 7 Newstone Cottages Ornamental Cherry - Reduce over hanging branches by 5 metres and reduce the crown by 2metres.
- DM/23/1854 Mr M Jones, The Old Manse, North Street T1 Cherry tree - Crown reduce canopy back to previous pruning points. T2 Acer - Lightly prune back lateral spreads and height by no more than 1 metre. T3 Variegated maple - Reduce height and lateral spreads by no more than 1 metre and prune out as much reverted green as possible. T4 multi-stemmed conifer -Try to pull back and tie in subsided limb (south) over hedge and if not possible, remove subsided limb only.
